

भागवत कथा - 5

योगमाया [12th, CTT (certified teachers training)]

यह भागवत की कथा का एक और प्रकरण है, 23 साल की योगमाया का। लूंगा, भद्रक जिले की निवासी योगमाया ने भी ब्रह्मा मुख द्वारा माउंट आबू से उच्चारित ज्ञान-मुरलियों की गहराइयाँ समझ कर आजीवन पवित्र रहने की इच्छा रखी थी। बेटी के व्यवहार से रूठे उसके पिता उसे ज्ञान से हटा कर शादी करने के लिए बंधन डालने लगे। योगमाया ने अपने पिता को समझाने के जो भी प्रयत्न किए, वे व्यर्थ हुए और अपने-आप को शादी से बचा कर ज्ञान में स्थिर रहने और ईश्वरीय सेवा करने के लिए कोई रास्ता न बचा सिवाय भागवत के। योगमाया को पता था उसके पिता चुप नहीं बैठेंगे। तो योगमाया ने रजिस्टर पोस्ट द्वारा उड़ीसा, कटक और फ़तेहगढ़, फ़र्रुखाबाद के पुलिस अधीक्षकों को पत्र भेजा, जिसमें यह स्पष्टीकरण दिया गया कि वह वयस्क है और ईश्वरीय ज्ञान में अपनी अटूट श्रद्धा के कारण और अपने पिता द्वारा दिए गए शादी करने के दबाव से बचने के कारण घर छोड़ फ़र्रुखाबाद स्थित आध्यात्मिक विश्वविद्यालय परिवार से जुड़ने और ईश्वरीय सेवा में समर्पित होने के लिए जा रही है।

This is about another girl (kanya) Yogamaya, aged 23 years, resident of Lunga, Bhadrak who decided to remain pure lifelong after grasping the depth of the Murlaies of knowledge through the medium of Brahma from Mt. Abu. Being averse to the pure intentions and firm attitude of his daughter, her father started pressuring her to get out of the spiritual knowledge and get married. Yogamaya's efforts to convince her father proved futile and no way out was before her except to escape (resorting to Bhagawat) from the proposed marriage and settle in her favorite spiritual knowledge and Godly Service. She knows well, her father would not remain silent.

In anticipation of her father's interference in her interests to be with the AVV family, she has addressed letters by registered post, both to Superintendents of Police at Cuttack, Orissa and at Fategarh, Farrukhabad, intimating them of her firm decision to stay with the AVV Family for her spiritual enlightenment and Godly Service on her own volition and being major by age. She has also expressed therein her firm resentment towards her father's pressure to get her married.

उसके पिता श्रीहरि भंज ने पुरुष थाने में दिनांक 26-08-2007 को कम्प्लेंट की कि उनकी बेटी उनके सरकारी क्वार्टर्स से गायब हो गई। यह कम्प्लेंट फिर उड़ीसा में, कटक जिले के दारगा बाजार थाने में ट्रांसफर की गई और दिनांक 29-11-2007 को भा.दं.सं. की धाराओं 363 और 365 के अंतर्गत प्रथम

सूचना रिपोर्ट (नं.64/07) दर्ज की गई। कन्या के पिता ने आरोप लगाया कि हरिपुर स्थित आध्यात्मिक विश्वविद्यालय के सदस्य लक्ष्मीधर पात्रा ने उनकी बेटी का अपहरण किया है।

Her father Srihari Bhanj, resident of Lunga, Bhadrak has lodged a complaint with the Police Station at Purugh, on 26th August, 2007 that his daughter is missing from his government quarters. The complaint has subsequently been transferred to the concerned Police Station at Darga Bazar, Cuttack District, Orissa. Accordingly the complaint was registered as FIR No. 64/07 on 29th November, 2007 with Darga Bazar Police Station under sections 363 and 365 IPC. The father of the girl (kanya) Yogamaya has alleged that Mr. Lakshmidhar Patra, a family member of the AVV, at Haripur has kidnapped his daughter.

लक्ष्मीधर पात्रा से जानकारी लेकर, विवेचक कन्या के माँ-बाप के साथ फर्रुखाबाद स्थित आध्यात्मिक विश्वविद्यालय में पहुँचे और विवेचक ने योगमाया के माता-पिता के सामने योगमाया का बयान लिया। योगमाया ने अपने बयान में स्पष्ट किया कि वह वयस्क है और अपनी ही मर्जी से आध्यात्मिक विश्वविद्यालय परिवार के साथ रह रही है और किसी ने उसका अपहरण नहीं किया है। कन्या ने अपने माँ-बाप के साथ घर वापस जाने के लिए मना किया। अंततः विवेचक ने फर्रुखाबाद के चीफ जुडीशियल मैजिस्ट्रेट के सामने दिनांक 31-03-2008 को दंड प्रक्रिया संहिता की धारा 164 के अंतर्गत योगमाया से बयान दिलवाया, जिस बयान में उसने ऊपर कही हुई बातें फिर से दोहराईं। उसके माँ-बाप भी उस समय कोर्ट में मौजूद थे। विवेचक ने इस प्रकरण की अंतिम रिपोर्ट दिनांक 24-06-2008 को कटक पुलिस उपायुक्त को सौंपी और इस तरह यह केस खत्म हो गया और फिर से आध्यात्मिक विश्वविद्यालय के सदस्य निर्दोष साबित हो गए।

The investigating officer has, on the information given by Lakshmidhar Patra, proceeded to Farukhabad "AVV" and recorded her statement in the presence of parents of Yogamaya. The girl (kanya) has specifically stated in the said statement given in their presence that she is a major and staying with the AVV at her own will and nobody has kidnapped her. She has refused to follow her parents back home. Ultimately the investigating officer has arranged to get her statement recorded under section 164 Crpc in the presence of Chief Judicial Magistrate, Farrukhabad on 31-03-2008 wherein Yogamaya has reiterated the same facts in her statement as referred above. Her mother and Father were very much present in the Court at the relevant time. The investing officer has accordingly submitted his final report to the D.S.P., Cuttack. And in result, the complaint lodged by the father of yogamaya was closed. And once again the "AVV" family member was proved flawless. However, the news published in the media is given hereunder.

18. *Brief Facts of the Case : est that on 29.11.07 at 12 A.M, Compti Sachini Bhojia of Durga, Choudhary HP. Choudhary Bazar alleging that one Karmakar potra has kidnaped her daughter Jogamaya Akhota age 23 from her Govt Atr located at Choudhary Bazar during their temporary absent from her at on 26.8.07. Initially he has reported the matter before the Panchayat PC. as reporting she go Atr Sr Nayan ascertained the place of occurrence. comes under Durga Bazar PS. Hence transferred to the PC on the point of investigation. Accordingly the case was registered under PC No. 64/07 U.S. 362/365 I.P.C and 3 have been directed to take up investigation. She spot with the police the case Govt Atr the Compti located at Choudhary Bazar.

During course of investigation 9 arrested the Compti as well as other family members of Compti proceeded to the village Hanipur the block Gokulam of Adhyatika Taluqa. During 400 p.m where 9 arrested the Karmakar potra and other accomplices who come to the house of Compti prior to the occurrence. Seizing Assistant and one destination from made the victim Jogamaya on production by Karmakar potra.

1. Proceeding Panchayat, received the victim Jogamaya Bhojia and recorded her statement U.S. 161 Cr.P.C. She has also produced before the court of CJM Panchayat on 31.3.08 for recorded her statement U.S. 161 Cr.P.C. in which she stated that on her own wish she has been in S.P.K.T. and institute for Panchayat and no body kidnaped her and does not agree to returned back her later place. Her parents was also present at Panchayat.

9 Submitting report regarding to D.C.P. Choudhary for passing order to stay the case as A.P.M.P. under the above fact and circumstances as she is minor and aged about 23 and on her own wish she has been in religious institute got the case after as A.P.M.P. after obtaining orders from D.C.P. etc. and submitted for A.P.M.P. U.S. 362/365 I.P.C.

18. Brief Facts of the Case: is that on 29.11.07 at 12 A.M. complainant Srihari Bhanja of Lunga, Bhodrok A/P. Choudhury bazaar alleging that one Laxmidhar patra has kidnapped his daughter Jogamaya Bhanja aged 23 from his Govt. Qtr located at Choudhary bazaar during their temporary absent from his Qtr on 26.8.07. Initially he has reported the matter before HC Paroghat PS. in writing. The I.O. A.S.I., S.K. Nayak ascertained of the place of occurrence comes under Dargha Bazar P.S. Hence transferred to this P.S. on the point of Jurisdiction. Accordingly the case was registered before P.S. with F.I.R No. 64/07 u/s 363/365 IPC and I have been directed to take up investigation. The spot in this case is the OMC Govt. Qtr of the complainant located at Chaudhary bazaar.

During the course of investigation I examined the complainant as well as the family members of the complainant and proceeded to the Village Haripur, the branch ashram of Adhyatmik Ishwariya Vidyalaya Haripur where I examined the Laxmindhar patra ... other associated who came to the house of complainant prior to the occurrence. Seized affidavit and the declaration form made by the victim Jogamaya on production by Laxmidhar patra.

I proceeded Farrukhabad rescued the victim Jogamaya Bhanja and recorded her statement u/s 161 crpc she has also produced before the court of CJM Farrukhabad as on 31.3.08 and recorded her statement u/s 161 crpc, in which she stated that on her own wish, ~~she~~ ^{she} was been

I submitted report to DCP cuttack praying for passing order to stay the case as PRMF.

Under the above facts and circumstances as she is major one aged about 23 and on her own will she has been to religious institute. The case after as PRMF after obtaining orders from DCP Cuttak and submitted as PRMF u/s 363/365 IPC.
